The Idealease Fuel Card automates the tracking of fuel tax receipts and is available to all Idealease customers—including heavy- and medium-duty truck fleets. The card is accepted at more than 43,000 fueling locations in North America, and has no transaction fee.

Fleet managers receive real-time, online reports that show key information such as: mileage per gallon, unauthorized purchases, and fuel purchasing by location and vehicle.

Fleet managers can access their account online to add or delete cards, set limits on how much fuel can be purchased per transaction, require PIN numbers for each transaction, or allow purchases of oil and/or minor repair items.

REPORTING AND COMPLIANCE SERVICES

Many of the time-consuming licensing, registration, and regulatory compliance reporting requirements for your fleet can be handled by Idealease Fleet Services. We provide:

- **Fuel Tax Reporting:**

This includes IFTA permit/decal procurement, fuel and mileage tax report completion and filing, IRP license credential procurement, and trip report collection and processing. Idealease Fuel Card customers who use Idealease Fuel Tax Reporting may not need to keep track of fuel receipts or trip reports.

- **Licensing and Registration Services:**

These include title processing, Federal Heavy Vehicle Use Tax (HVUT), Unified Carrier registration for new and renewal units, trip permit processing, and other mandatory compliance functions.

- **Motor Vehicle Reports (MVRs):**

Required for rental drivers if the rental company is providing vehicle insurance. According to FMCSA 49 CFR, carriers that employ drivers are required to maintain annual MVRs on each driver. Idealease Fleet Services ensures that your drivers will be on the road quickly by providing our members with next-day turnaround on MVRs for 48 states and one-to-three day turnaround for the nine provinces in Canada.

TELEMATICS SERVICES
